


BACKGROUND TO QUESTION 2 PRESENTED BY: ELIZE LOURENS

- Organised Labour keen to adopt strategies that will ensure descent work
- GHS classification reduces the need for testing of agents
- Standard way to assess hazard, and communicating hazards (Common understanding)
- Hazard level similar therefore risk reduction measures can be shared for the same hazard class within countries, industry.


Zambia's experience in implementing GHS:

In 2001, Zambia was selected as one of the pilot countries to receive assistance from UNITAR and ILO to develop and implement a National Chemical Hazard Communication and GHS Action Plan.

This task involved a baseline study on the existing chemical hazard communication in the industrial, transportation, agricultural and consumer sectors

The objective was to conduct a situation analysis and develop National Implementation Plan for GHS.
